YOUR VOICE CAN MAKE A DIFFERENCE TODAY!

We delivered a red rose and an invitation to all our lawmakers today. They know we are here, but YOUR attendance makes a difference when your legislators know you showed up. Here are some ways for you to communicate with them:

1. WHEN TALKING TO YOUR LEGISLATORS

Please remember to speak truth in love and to show respect for their inherent human dignity whether they agree with you or not.

2. VISIT YOUR LEGISLATORS' OFFICES IN PERSON

Don't know where your Senator and two Representatives' offices are located? Call 1-800-562-6000, visit <https://app.leg.wa.gov/DistrictFinder/> or ask the Visitor Services' volunteer seated at the desk located just inside the Legislative Building main doors for assistance. **IMPORTANT:** No signs or sticks are allowed in the Capitol Building. Please leave them outside the doors and remember to take them when you leave.

3. CALL LEGISLATIVE HOTLINE AT 1-800-562-6000.

If your schedule doesn't allow you time to visit your legislators in person, you can leave a message for all three and the Governor.

IN THIS 2019 LEGISLATIVE SESSION YOUR LAWMAKERS MUST KNOW:

We **support** bills that **respect the infinite value of every person**, no matter their age or stage in life. This applies to people no matter their size, location, income, gender, ethnicity, or any other factor. This is particularly true for **the most vulnerable among us** who cannot speak for themselves.

As pro-lifers we are in **full support of high-quality healthcare** for women, men and children. We are **100% opposed to forcing any individual to pay for someone else's abortion.**

Please state that you **oppose any bill that makes people a commodity to be bought and sold**, such as those regarding surrogacy or otherwise. Each and every life is infinitely valuable we must not begin to judge humans on a sliding scale of economic value. This devalues everyone. **People are not property.**

We SUPPORT bills that protect the unborn and protect the citizens of Washington State from participating in abortion including:

- **Senate Bill 5185 Parental Notification** for minors during abortion. Too many lives are at risk without this common-sense law that helps protect minors during this potentially dangerous procedure. Nearly all other states have similar laws and it is time for Washington to stop falling behind here..
- **Stopping taxpayer funding for abortion businesses:** We should be funding high-quality, accessible healthcare, like the many federally qualified clinics (over 13,000 nationally) that serve the needs of all.
- **Prohibiting the sale of unborn human remains.** For too long shady businesses have been profiting off the crisis of others right here in our state. It must end. People are not for sale.
